Monthly Summary to the Cabinet for the Month of September, 2022

1. **Important policy** : NIL

2. **Important Achievements:**

- I. All India arrival of seed cotton was around 4.61 lakh bales. Cumulative arrival of cotton, this season from October 2021 to September 2022 has been 312.08 lakh bales. This is approx. 12% less as compared to corresponding period of last year. Since the price of cotton in the market is ruling above MSP, **Cotton Corporation of India (CCI)** has not procured cotton under MSP operations during September, 2022.
- II. A Working Group recommending measures for promoting **sustainable technology** in textile value chain has been constituted under the chairmanship of Joint Secretary, Ministry of Textiles. Working Group will formulate the contours for a new policy/scheme for promoting sustainable technology in textiles manufacturing across the value chain.
- III. 3rd meeting of Mission Steering Group (MSG), under the Chairmanship of Hon'ble Minister of Textiles was held (through Hybrid Mode) at New Delhi on 14th September, 2022, wherein 23 research proposals amounting to the tune of Rs. 60 Crores were approved under **National Technical Textiles Mission**.
- IV. In order to promote Handlooms in domestic and overseas market, one International event "**Who's Next Paris**", France during the 2-5th September, 2022 was organized by Handloom Export Promotion Council, Chennai.

Under the **Weavers' Mudra Scheme**, in September 2022, 558 number of MUDRA Loans were sanctioned.
- V. **Central Cottage Industries Corporation of India (CCIC)** organized "Handloom Expo-2022" at its flagship showroom at Jawahar Vyapar Bhawan, Janpath, New Delhi from 28.09.2022 to 11.10.2022 wherein more than 70 weavers have participated. The exhibition was inaugurated by Hon'ble Secretary (Textiles) on 28.09.2022 in presence of Senior officials of Ministry of Textiles.
- VI. Under **Production Linked Incentive (PLI) Scheme**, 64 applicants were selected and letters of approval were sent to 54 selected participants in September, 2022. Investment to the tune of Rs. 1367 crore approximately has been made.
- VII. Under **Special Campaign 2.0**, Ministry of Textiles has identified various matter for disposal during the month of September, 2022. Out of total pending matter, there are 46 MPs References, 32 Parliamentary Assurances, 24 Public Grievances, 1 PMO References, 21 Public Grievances Appeals, 30,542 Physical files and 4927 E-files due for review. 333 Cleanliness Campaign(s) have also been identified.
